Food for Others ("we," "us," "our") owns and manages www.foodforothers.org (the "Site"). This page informs you of our policies regarding the collection, use, and disclosure of Personal Information we receive from users of the Site. We use your Personal Information only for providing services, assistance to you, and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

While using our Site, we may ask you to provide us with certain personally-identifiable information that can be used to contact or identify you. Personally-identifiable information may include, but is not limited to, your name, email address, postal address, and phone number ("Personal Information").

We may also collect general information about your use of the website, including log data, Google Analytics demographics and interest reporting. For example, your IP (Internet Protocol) address is used to gather broad demographic information such as the geographic location of our Site visitors and what type of internet browser our visitors use. This information helps us to better maintain and update our Site to be user-friendly and relevant. IP addresses do not provide us with any identifiable Personal Information, thus keeping visitors anonymous.

We have a strict policy against buying, selling, or sharing mailing lists and Site visitor information. Under this policy, Personal Information provided to us is NEVER shared or sold to any other organization – public, private, or nonprofit. We may permit certain trusted partners to access your information in connection with their performance of services to maintain and operate the website and certain features on the website.

We do not otherwise disclose any Personal Information or any information about your individual website visits except when we believe in good faith (1) that the law requires such disclosure or (2) that such disclosure is necessary to protect the rights and property of Food for Others.

Cookies

Cookies are electronic files with small amounts of data, which may include an anonymous, unique identifier. Cookies are sent to your browser from a website and stored on your computer's hard drive.

Like many websites, we use cookies to collect information. You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. Each browser is a little different; your browser help menu can help you learn the correct way to modify your cookie settings. If you turn cookies off, you may not have access to many features that make your Site experience more efficient and some of our services may not function properly.

The credit card information provided by you to Food for Others is not stored on our servers. Food for Others uses the Classy online fundraising tool to manage online donations and ticket purchases. Stripe is the third-party credit card processor used by Classy. Our employees cannot access your credit card information. We maintain physical,

electronic, and procedural safeguards to protect your information, and our employees are required to follow these privacy standards.

The information resources of the Site are provided to facilitate the philanthropic work of Food for Others. Use of the information presented in our web pages is for your personal use, the individual reading these pages. Use of information from this Site for commercial purposes, other than those approved by Food for Others, is not permitted.
